SUPPLEMENTARY REGULATIONS

1 Jurisdiction: Held under the National Sporting Code of the auto cycle union, the Standing Regulations, supplementary regulations and any final instructions issued. The ACU sporting code and standing regulations are published annually in the ACU handbook.

2 Eligibility: Open to all solo classes and youth members of a southern centre ACU club.

3 Entries: Through the ACU on line entry system only, there will be **NO** entry on the day. Entries open 19th January and close on 18th Feb or when full. Entry fee **£17 adult/£7 youth**.

4 Course: All on private land at Ashley Hollow, Ringwood, Hants, BH24 2DF. signposted from the B3081 junction with the A31 one mile south-west of Ringwood. **Maximum 100 riders**, 4 routes, 4 laps, 10 sections.

5 Classes: Expert, Clubman, Sportsman, Beginner, Twinshock, Pre- 65, Youth. **Route options as detailed below.**

6 Awards: Committee Cup – Best Expert Performance; Brownsey Cup - best Ringwood MCC member. Other awards as per centre ruling.

7 Results: Will be posted on the website – ringwood-mc-lcc.co.uk.

8 General: Toilets and catering at this event.

9 Child Protection: The Secretary of the Meeting is the point of contact (National Sporting Code 6.14)

10 Additional instruction page: Please ensure that you have read and follow all instructions contained on this page.
